**PRIVACY NOTICE: PERSONAL DATA PROTECTION ACT 2010**  
**VENDORS / SUPPLIERS / DISTRIBUTORS / SERVICE PROVIDERS**

1. GENERAL

This notice is issued to all vendors, suppliers, distributors, and/or service providers of Prolintas Group of Companies which includes Projek Lintasan Kota Holdings Sdn. Bhd., its subsidiaries and affiliate companies, existing presently and/or at a future date (hereinafter referred to as the "Company"), pursuant to the statutory requirements under the Personal Data Protection Act 2010 ("Act").

The Act regulates the collection processing and storage of all personal data which may occur during a commercial transaction. Under the context of the Act, '*commercial transactions*' mean any transaction of a commercial nature, regardless of whether it is contractual and this may include the collection of personal data of potential customer.

2. YOUR PERSONAL DATA

During the course of your dealings with the Company, your personal data may be collected, processed, and stored by the Company for the purpose of facilitating the Commercial Transaction, including but not limited to communicating with you, engaging you to provide products and/or services to the Company or on the Company's behalf, responding to your enquiries or complaints or to resolve any disputes, processing your invoices in relation to the sale/supply/distribution of your products and/or services, and other purposes required to operate and maintain the Company's business or as required by law or regulations ("Purposes").

You will be a "data subject" and all collection, processing and storage of your personal data will be subjected to the Act. Integral to the Act is the requirement of your consent to be obtained. In all circumstances, you will have the control over the disclosure of your personal data to the Company and such collection of personal data will subject to the procurement of your consent.

**You are therefore advised to read and understand the following contents carefully, before signing and date the Declaration of Consent form where shown, to indicate your consent and understanding of the contents.**

3. DESCRIPTION OF PERSONAL DATA

By virtue of the Act, the Company is required to obtain your explicit consent to collect, process and store your personal data.

The personal data shall refer to any details that can identify you and include but are not restricted to: - name, identification number (NRIC), EPF number, SOCSO number, income tax number, address, contact numbers, date of birth, place of birth, personal email address, and etc.

Some of the personal data that may be collected, processed and stored may include '*sensitive personal data*' which is defined by the Act. These include but are not restricted to race, religion, health, political opinion, records of criminal offence, bankruptcy record, and etc.

#### 4. DISCLOSURE OF PERSONAL DATA

In order to collect, process, and/or store your personal data for the said Purposes or other purposes that fall within the definition of '*commercial transactions*' under the said Act and subsequently to continue performing the contractual agreements entered between you and the Company (wherever applicable), the Company may need to disclose your personal data to other entities ("External Parties").

The External Parties include but are not limited to (1) governmental and regulatory bodies such as Bank Negara Malaysia, Securities Commission, Lembaga Lebuhraya Malaysia, Kementerian Kerja Raya, and/or Jabatan Kerja Raya; (2) the Company's business strategic partners such as Permodalan Nasional Berhad and/or any of its subsidiaries/affiliates, (3) any third-party service provider, agent or contractor who has been appointed by the Company or its related, associated or affiliated companies to provide products/services in relation to our day-to-day business operation and vice versa; insurance companies/takaful operators, third-party claims adjusters, fraud detection and prevention services, reinsurance/retakaful companies and regulatory authorities; any credit reference agencies or, in the event of default, any debt collection agencies; any credit rating organisations that collect information about credit history, accident fault, and any other descriptions as may be required by our insurance companies or takaful operations and others entitled to see it in; any assignee, nominee and such other third parties of our rights or business; any person to whom the Company is under an obligation to make disclosure under the requirements of any law, rules, regulations, court order, codes of practice or guidelines binding on us.

These External Parties may be required to locate, store, maintain and/or process your personal data within or outside of Malaysia.

#### 5. PROVISION OF PERSONAL DATA

In order to effectively engage you to provide products and/or services to the Company or on the Company's behalf, and to process your personal data for any of the Purposes, the Company requires that all the personal data be provided.

Should you choose not to furnish and/or fail to supply the Company with the requested personal data, or withhold your consent to allow the Company to process your personal data (including explicit consent for sensitive personal data), the Company will not be able to perform its obligations/services/products, whether contractual or non-contractual to you, nor will the Company be able to collect, process and store your enquiries and/or complaints, and/or to resolve disputes arising between you and the Company.

Accordingly, if it involves contractual obligations between you and the Company, it may necessarily mean that the contract will have to be terminated due to frustration of contract or if it involves an offer of employment, such offer will not be made or retracted.

#### 6. REVIEW OF NOTICE

The Company also reserves the right to review and/or amend this Notice as may be determined by the Company from time to time.

I further confirm that all Personal Data that I have provided are all true, up-to-date and accurate, and that I have duly obtained consent of other third-parties (including family members) contained herein for the use and disclosure of their personal data, including obtaining consent on their sensitive personal data to be processed by the Company for the said Purposes.

In the event of any changes to any of my personal data, I will notify the Company promptly.
